

## WHAT IS FASTRIKE?

Your Alabama Rural Electric Credit Union introduces a new way to add time and convenience to your busy schedule — it's Fastrike, our ATM and Debit Card. Fastrike is a popular, does-it-all card that works as an ATM and a credit card.

### GET CASH WITH YOUR FASTRIKE ATM CARD.

Use the new Fastrike card at any ATM on the internationally popular CIRRUS® network, PULSE network or Co-op network to ...

- Withdraw cash from savings or checking;
- Inquire about savings or checking account balances;
- Transfer funds between savings and checking;

You'll be asked to enter your secret personal identification number anytime you use your Fastrike ATM/Debit card to prevent unauthorized use at an automated teller machine.

### MAKE PURCHASES WITH YOUR FASTRIKE DEBIT CARD.

The new Fastrike is also a debit card — often called a "check card" because you can use it to deduct purchases from your checking account — that works just like writing a check, only faster. Simply swipe your Alabama Rural Electric Fastrike card through the point-of-sale device at any participant or merchant where VISA debit cards are honored. Your purchase amount will be instantaneously deducted from your account, and you'll be given a receipt to assist you in balancing your checkbook.

Fastrike is quicker, easier and safer than writing a check... and one card lets you get cash or make purchases. What could be easier?

### FASTRIKE DEBIT CARD APPLICATION

You hereby request that an ATM/VISA Debit Card(s) be issued, or if already issued, that such card(s) be validated and a Personal Identification Number (PIN) be issued; for the (joint) account(s) and (joint) account holder(s) designated below. The retention or use of such Card(s) shall be governed by the printed terms and conditions of the ATM/VISA Debit Card Agreement and the Regulation E Disclosure Statement attached along with such other terms and conditions, or amendments thereto, as may be established from time to time by the Credit Union and communicated in writing to you.

By signing this application you authorize Alabama Rural Electric Credit Union to check your credit and employment history and make whatever inquiries necessary in the course of granting the ATM card, reviewing its use, reissuance or cancellation. You understand that the Credit Union will retain this application whether or not it is approved. You also agree that if you are approved for an ATM/VISA Debit Card that your use of that card will bind you to all terms and conditions contained in the ATM/VISA Debit Card Agreement and the Regulation E Disclosure Statement and will retain it for your record.
